Proposed Membership Bylaw Change

The Board is proposing a change to the Membership bylaw that would allow non-homeowners and previous Chartley residents to become members. The change would be as follows:

Current:

ARTICLE III- MEMBERSHIP

Section 1. Membership in the Association shall be open to any adult individual(s) 18 years of age or older, *owning* a home within the bounds of Chartley as defined. Chartley's boundaries are set out in a plat entitled "Chartley" which is duly recorded in the land Records of Baltimore County.

Proposed:

ARTICLE III- MEMBERSHIP

Section 1. Membership in the Association shall be open to any adult individual(s) 18 years of age or older, *currently or previously residing in* a home within the bounds of Chartley as defined. Chartley's boundaries are set out in a plat entitled "Chartley" which is duly recorded in the land Records of Baltimore County.

There are reasons to make the change at this time.

• There are currently non-owners making their homes in Chartley.

- Home prices and projected rising interest rates are forcing some younger home buyers to rent or rent with an option to buy.
- Having a safe and attractive community is in their best interest. Maybe some of them will choose to become members and contribute to the community in this way.
- Previous residents who have moved out of Chartley have expressed a desire to remain members. They are generally people who were active members who made friends and enjoyed lending their time and talents to the neighborhood and would like to continue the relationship.
- The additional dues would help funding for activities and scholarships

Opening memberships to more than just homeowners, the organization name doesn't represent the diversity of the members. Therefore, the Board is suggesting registering a trade name of "Chartley Neighborhood Association" which we feel would be more inclusive. Our official registered business name would remain Chartley Homeowners Association with our trade name being our doing business name. An example would be the legal business name of Wal-Mart, Inc with a trade name of Walmart.

Another advantage would be that it would separate us from the traditional HOA which are mandatory, have high dues and covenants. Chartley adheres to Baltimore County codes and has a process in place to reports complaints and violations to the county code enforcement.

The bylaws change will be brought to a membership vote at the April General Meeting on April 21, 2022.

CHA Scholarships

Each year, the Chartley Homeowners Association offers two scholarships to graduating high school seniors from the Chartley community. The Joseph S. Mo-

linaro and the Phyllis Daly Memorial Scholarships each provide a deserving graduate a cash award of \$1,000.



To be eligible for a Chartley Scholarship, applicants must meet the following requirements:

- 1. Parents/legal guardians of the applicant must be homeowners in the Chartley community and the applicant must reside in the Chartley community.
- 2. The applicant's household must be a current duespaying member of the Chartley Homeowners Association on or before December 1, 2021.
- 3. The applicant must be a senior in high school (Franklin, Owings Mills, Baltimore County magnet, private, home school)

TO PRE-REGISTER

We are asking all who wish to participate to pre-register by going to www.countryclubestatesreister-stown.org and completing the Registration form found there. Registration is quick and easy, and will allow us to advertise your location to potential buyers to help them find you on the day of the event. Please note that we will **NOT** publish your name, phone number, or email address...only your location and the types of items you wish to sell.

What you need to do

If you wish to participate, all have to do is clean out your unused or unwanted items, move them out in front of your house and begin collecting the money

The event will start at 8:00 AM on both Saturdays and last until each participant decides to call it quits.

So, start planning now! Mark the dates above on your calendar and please remember to go to the preregistration site and fill out the form. Residents who have pre-registered for previous yard sales have told us that pre-registering brought more potential buyers to their location than when they did not pre-register for past yard sales.

Crime In Chartley

Chartley residents reported four crimes during January. Three of these were non-domestic assaults and the fourth was a theft. Two of the three non-domestic assaults took place in the 200 Block of Highmeadow Road, while the third was reported on Walgrove Road. Once again, we would like to remind everyone to always be aware of your surroundings wherever you may be, but particularly when in shopping centers or when using ATM machines. The theft was reported in the 100 Block of Walgrove Road.

During the January meeting of the Police Public Relations Council, Captain Buckingham stated that the police are experiencing an increase in the theft of vehicles that are left unattended while being warmed up due to the cold weather. Leaving a vehicle running unattended gives criminals a golden opportunity to take advantage. In addition to losing their vehicle, leaving a vehicle running while unattended is considered a crime and can result in a \$70 fine. Most vehicles today will warm up very quickly when they are driven, but will take considerably longer if they are being warmed up in someone's driveway. So, why take the chance? Don't give the criminal element the opportunity to spoil your day.

Theft from unlocked vehicles continues to be a concern throughout the Precinct, although none were reported in Chartley during January. In addition to taking valuables and loose change from these unlocked vehicles, some instances were noted where the thief also stole the vehicle because a spare set of keys to the vehicle were left in the console or glove box. Never leave keys to any vehicle, house, or shed inside any vehicle.

Captain Buckingham also asked everyone to take appropriate measures to properly safeguard any packages that you expect to be delivered to your home. Those protective measures may involve having the package delivered to a trusted neighbor who will be home when the package is delivered, or to have that neighbor pick up the package from your front porch when it is delivered. Residents may also want to consider other options such as a secure carrier drop box for the delivery of packages to deter theft. The Captain also said that the use of outside video cameras such as doorbell cameras has greatly aided the police in catching these so called 'porch pirates' as well as in helping them solve other types of crimes as well.

The police have also noted an increase in the theft of utility trucks, larger trucks or other heavier duty vehicles which may be used in the theft of ATM machines that seems to be spreading throughout Baltimore City and County.

With crime continuing to spread nationwide, it is important that each of us take every precaution NOW to avoid becoming a crime victim or having our loved ones become a victim. Once again, we urge everyone to adopt the following Crime Prevention Tips. And pass them along to friends and relatives...these tips work!

- Lock it up, each time, every time.
- Keep the outside of your house illuminated after dark.
- Strongly consider the installation of home security cameras around your property.
- Never leave your vehicle running unattended.
- Never leave valuables in your vehicles.
- Never leave the keys to any property inside your vehicle.
- Be aware of your surroundings wherever you are, particularly when you are outside or shopping after dark.
- NEVER, EVER, FOR ANY REASON, GIVE ANY PERSONAL INFORMATION WHATSOEVER TO ANYONE UNTIL YOU HAVE VERIFIED THE SOURCE FIRST
- If you see something, say something! Call 911 each time, every time.
- not be a police response... no response... no police follow up to prevent further crimes...MAKE THAT CALL, EACH TIME, EVERY TIME. And call 911 even if you do make a mistake and the criminals take advantage of you. Never be too embarrassed to make that call. You could be helping someone else by allowing the police to start closing the ring on the criminals. MAKE THAT CALL!

Removal Of Snow and Ice



Within **24 hours** after the fall of any snow, each person occupying a residential building shall remove and clear away, or cause to be removed and cleared away, the snow or ice from the foot pavements fronting streets in the county.

In removing or clearing the snow or ice, the person may not:

- Obstruct the passage of water in gutters along the street; or
- Throw the snow on the paved portion of the street. If the person does not remove and clear the snow or ice, the county may do so at the expense of the person.

In addition to the other remedies provided in this section (Baltimore County Code 18-3-107), a person

who fails to comply is guilty of a misdemeanor and subject to a fine for each failure and an additional fine for each day the obstruction continues.

"§ 18-3-107. REMOVAL OF SNOW AND ICE

- (a) Required. Within 24 hours after the fall of any snow, each person or public institution occupying or using a residential, commercial, or industrial building in any manner or for any purpose shall remove and clear away, or cause to be removed and cleared away, the snow from the pavements fronting the respective houses, stores, shops, stables, houses of worship, lots occupied by any buildings, unoccupied buildings, and unoccupied lots that run along streets in the county.
- (b) Manner of removal. In removing or clearing the snow, the person may not:
 - (1) Obstruct the passage of water in gutters along the street; or
 - (2) Throw the snow on the paved portion of the street.(c) County may remove. If the person required to remove and clear snow under this section does not remove and clear the snow, the county may do so at the expense of the person.
- (d) Expense a lien.

- (1) If the person does not pay the expense incurred by the county for snow removal under this section, the expense shall be a lien on the property in the same manner as taxes, and shall be collected in the same manner provided by law for the collection of taxes.
- (2) Charges and assessments imposed under this subsection are benefit charges and may not exceed a reasonable estimate of the special benefit conferred on the property.
- (e) Removal of ice. The person required to remove and clear snow also shall keep ice and every type of obstruction out of the gutters leading to and off the pavements or sidewalks located in front or at the rear or sides of the same buildings.
- (f) Penalty. In addition to the other remedies provided in this section, a person who fails to comply with this section is guilty of a misdemeanor and subject to a fine of \$25 for each failure and an additional \$25 for each day the obstruction continues.(1988 Code, § 31-8) (Bill No. 3, 1990, § 2; Bill No. 66-01, § 2, 7-1-2004)
