Crime In Chartley

BIG TIME KUDO'S to Ernie Schmidhauser and his entire team for an outstanding National Night Out event that was held on August 2nd! (See the article on Page 1). This annual event takes many months to plan, coordinate, and to successfully bring to our Community. It is designed to foster community relations between the police and the public. Despite temperatures in the 90's, the event drew a large crowd, many of whom stopped by to chat with the Precinct 3 Police officers while their excited children were crawling thru a police car! Several of the police officers told me that they really enjoyed the event, especially the opportunity to talk to citizens on an informal basis and to hear their thoughts and concerns,

Now back to Crime in Chartley. Two thefts were reported in Chartley during July. One was a theft from

a resident's bank account and the other was a general theft in the 300 block of Janet Rd. Theft, particularly general theft (e.g. theft of a bicycle from someone's yard) has been the most commonly reported crime within our community since the beginning of the year. So far, 11 out a total of 16 reported crimes have been the general type theft. While our overall crime rate has been low compared to previous years, now would be a good time to look around your property and make sure that you are taking the proper precautions to safeguard it. As always, LOCK IT UP EVERY TIME!

Our COP Program works with the Outreach Team at Precinct 3 to track crime throughout the area in order to try and alert YOU of any negative activity BEFORE it occurs in our community. But our primary source of information is YOU as a Chartley resident. If we aren't made aware of something that is going on, then our ability to effectively work with the Precinct 3 officers is severely hampered. As the saying goes, "If you see something, say something" by first calling 911 to report it. If in doubt, let the police check it out. Then follow up by sending me the information at davidlpowers@verizon.net. That will help me to coordinate with the police as may be appropriate.

One of the tools we use to help us track crime is social media. Quite frequently, someone will put a post on one of the social media available that indicates that they have been a victim of a crime, or that their security cameras picked up something that appeared suspicious. On most of these occasions, there are follow up posts by other readers expressing their dismay, sometimes disparaging the Reisterstown area as a ghetto, etc. Not until a number of such replies have been posted does someone finally ask if the "victim" had called the police. Quite frequently, the post originator indicates they just wanted to let everyone know what was going on and that 'no' the police have not been notified! Each time I see these posts I have to always ask myself WHY? Why post something on social **before** calling the police if something appears suspicious, much less if a crime is being, or has been, committed. Make that call right away, then post on social media if desired. That could actually save someone's life, much less result in arresting the criminal.

We continue to receive complaints about fireworks being set off both in our community as well as in surrounding communities, sometimes late at night. Please remember that **DISCHARGING FIREWORKS OF ANY KIND IN BALTIMORE COUNTY IS** **ILLEGAL!** This includes all fireworks such as any hand-held or ground-based device that creates an explosion, detonation, loud noise, that launches a projectile or moves along the ground under its own power. Fireworks can, and have caused serious injuries, even some deaths, as well as setting homes or sheds on fire. And dogs are not very fond of them either! If you hear fireworks being discharged at any time, please try to determine the approximate location and report it to 911 right away. The fine for setting off fireworks is \$250 for the first offense, and a hefty \$1000 for the 2nd offense

As always,

- Lock it up, each time, every time.
- Keep the outside of your house illuminated after dark.
- Strongly consider the installation of home security cameras around your property.
- Never leave your vehicle running unattended.
- Never leave valuables in your vehicles.
- Never leave the keys to any property inside your vehicle.
- Be aware of your surroundings wherever you are, particularly when you are outside or shopping after dark.
- NEVER, EVER, FOR ANY REASON, GIVE ANY PERSONAL INFORMATION WHATSOEVER TO ANYONE UNTIL YOU HAVE VERIFIED THE SOURCE FIRST.
- If in doubt, let the police check it out!
- If you see something, say something! Call 911 each time, every time.
- Remember that if you don't call 911, there will not be a police response... no response... no police follow up to prevent further crimes...MAKE THAT CALL, EACH TIME, EVERY TIME. And call 911 even if you do make a mistake and the criminals take advantage of you. Never be too embarrassed to make that call. You could be helping someone else by allowing the police to start closing the ring on the criminals. MAKE THAT CALL!

Baltimore County Concrete Replacement Program

Concrete Replacement Information

The repair and maintenance of sidewalks, pedestrian pathways and driveway aprons within the Baltimore County right-of-way are the responsibility of each respective property owner. All sidewalks, pathways and driveway aprons must be maintained in a safe condition, free from obstructions and tripping hazards as defined in the **Americans with Disabilities Act**.

To aid the property owner in the repair and maintenance of sidewalks, pathways and driveway aprons, Baltimore County offers a program that allows the property owner to request that the necessary repairs be made by the Bureau of Highways. Upon application, arrangements will be made with a County-approved contractor to complete the work, per Baltimore County Standards and Specifications. The costs incurred will be placed on the property tax bill, spread evenly over a five year period, interest free.

Schedule an Appointment

Call the Bureau of Highways at **410-887-3560** or send an email to highways@baltimore-countymd.gov to schedule an appointment with a representative to complete the application at your residence.

The cost for concrete sidewalk replacement is \$6.50 per square foot. The cost for driveway replacement is \$9.50 per square foot.

Typically, there is a waiting period of up to one year before the work can be completed under this program; however, should you choose not to wait, you may hire a private contractor at any time.

Tree Damage

For damages to the concrete driveway or sidewalk from trees, please view the information on <u>tree</u> <u>removal</u>, or contact the Bureau of Highways by phone at 410-887-3560 or by email at <u>highways@baltimorecountymd.gov</u>.

Chartley Drive Traffic Calming Speed Humps have been installed


A few weeks ago, Baltimore County DPW installed speed humps on Chartley Drive similar to what was done on Glyndon Drive. **Joseph Chester** on Chartley Drive took leadership to get the map from DPW of the



locations and petition for residents to sign. It was necessary for him to obtain 75% of the streets approval and he accomplished this quickly very everyone wants to slow traffic as the cars drive past our homes. First comments by residents on Chartley have been that it is successful.

Standard speed humps like you see on Glyndon Drive have been installed in front of 107 Chartley Drive and near 235 Chartley Drive.

The other locations are crosswalks for students so



they will be different with brick borders. One will put a hump over the entire intersection at Shirley Manor and Chartley Drive. Be careful as you approach as there are still only Stop signs on Shirley Manor.
